- Establish and maintain a culture and operating process that keeps focus on health and safety issues
- Investigate, recommend and implement operating regimes that minimise cost and maximise EBIT at the contract. Work with internal and external customers to ensure that operations are best utilised to enhance profitability and maximise resource and asset capacity.
- Maintain the performance standards of the contract, as measured by complaints, defaults, recycling targets etc
- Liaise with the fleet department on all aspects of the vehicle fleet including servicing, maintenance and legislative requirements
- To ensure maximum efficiency in the deployment of human resources through effective recruitment & selection, performance management, communication and team building
- To equip employees with the necessary skills to fulfill their roles through training, coaching and mentoring
- Accurate and up to date record keeping and completion of all associated paperwork
- To undertake periodic site audits of documentation to ensure compliance and efficiency and actively take steps to improve any deficiencies or non-compliances
- To undertake professional and personal development by improving knowledge of the waste management industry by holding membership of professional bodies i.e. the IWM, in order to develop improved working practices in waste handling and treatment. To undertake relevant training and hold the appropriate required qualifications.
- Maintain regular meetings with the client in order to build a sound relationship and understand the client's needs, so as to maintain a long term contract/partnership.
- To ensure good systems of management are in place at the location to deal with the both geographical and customer complexities
- To liaise with other external bodies as required
